




Trade mark filings




Trade mark application by origin

This overview shows where the major part of trade mark applications come from. The filings that are not filed by owners of the domestic market are split by filings coming from the partner countries or those filed by owners located from other parts of the world.



Average number of classes per application




Direct Filings International Registrations

A difference can be observed by trade mark office by the number of classes included per application. The international registrations related to CNIPA, JPO, KIPO and USPTO have on average at least one more class included in each application.

EUIPO has slightly more classes included per direct application than compared to International registrations.

Trade marks registered




Trade marks in force




The number of trade marks in force represent all valid registered trade marks. Valid means those not being expired, cancelled or invalidated .

Non-traditional trade marks





Renewal rates






A trade mark is registered for a given period of time (generally 10 years) from the filing date of application. The trade mark may them be renewed for another period, has eventually been renewed.
